Mr. Regmon Chaney, Chair, called the Civil Service Board meeting to order at approximately 6:30 p.m. He called for a moment of silent prayer and Pledge of Allegiance. Dayna Parker, Personnel Officer read the meeting protocol.

The first item on the agenda was Personnel Updates. Dayna Parker, Personnel Officer, provided an update on employees that were made above entry. Ms. Parker also shared the new Performance Evaluation Process that was implemented in 2023 and will continue in 2024. Finally, as part of the Personnel updates, Ms. Parker shared the implementation of a new HR and payroll system, Paycom. This system will allow employees improved access to their benefits and insight into their pay information while providing various self-service tools. Investing in this new system will enhance the overall experience of our employees and align with the Parish President's goal of streamlining and utilizing technology more effectively throughout the organization. The board asked for continued updates on the implementation. In addition, the board asked for updates on Insurance offered to employees at the next meeting.

The next item on the agenda was the request for approval of minutes from the June 11, 2024 meeting. After discussion was completed, a motion to approve the minutes was made by Brett Terrebonne and seconded by Sara Champion. After voting, the motion was approved unanimously

with four votes. Patrick O'Malley abstained from voting due to being absent at the June 11th meeting.

The next item on the agenda was the request to update Civil Service Rules and Regulations Section 7.02.a Annual & Sick (Employees Hired After 1-1-95). Ms. Parker explained this will allow employees to earn annual and sick time every payroll rather than wait until the quarter ends. The earning of the annual and sick will be based on the number of hours worked during the pay period. After discussion was completed, a motion to approve the request was made by Brett Terrebonne and seconded by Patrick O'Malley. After voting, the motion was approved unanimously.

The next item on the agenda was the request to update Civil Service Rules and Regulations Section 7.02.a. Annual & Sick (Employees Hired Prior to 1-1-95). Ms. Parker explained this will allow employees hired prior to 1995 to earn their sick time every payroll rather than wait until the quarter ends. She also explained that employees hired prior to 1995 are given their vacation time in January and this will not change. After discussion was completed, a motion to approve the request was made by Patrick O'Malley and seconded by Brett Terrebonne. After voting, the motion was approved unanimously

The last item on the agenda was a request to adjourn. A motion to adjourn was made by Brett Terrebonne and seconded by Sara Champion. After voting, the motion was approved unanimously.
