Mr. Breaux, Chairperson, called the Civil Service Board meeting to order at approximately 6:30 p.m. He called for a moment of silent prayer and pledge of allegiance. Mr. Breaux asked for the reading of the meeting protocol. The Meeting Protocol was read by Dayna Parker, Personnel Officer.

The first item on the agenda was the request for approval of the minutes from the July 9, 2019 meeting. A motion was made by Dr. Schonberg and seconded by Mr. Wilderson to approve the minutes. Motion carried. Minutes were approved unanimously.

The next item on the agenda was a request for approval of a new job description – GPS Field Technician. Luis Martinez, Director of GIS, was available to answer questions from the Civil Service Board regarding this request. Snookie Faucheaux, Director of Public Works, also came to the podium to

speak on this request. Following discussions, a motion was made by Ms. Champion and seconded by Dr.

Schonberg. Motion carried. The new job description was approved unanimously.

The next item on the agenda was a request for approval of a revised job description,

Administrative Assistant. Dayna Parker explained the rationale for the revisions to this job description.

A motion was made by Dr. Schonberg and seconded by Mr. Terrebonne. Motion carried. The revised job

description was approved unanimously.

The next item on the agenda was a proposed change to Civil Service Manual Section 7.01

Holidays. Mr. Terrebonne presented his proposed change and rationale. Councilman Paul Hogan came

to the podium to speak on this agenda item. After further discussion, Dr. Schonberg recommended

specific verbiage for the change.

"Section 7.01. HOLIDAYS: The Parish President may declare additional holidays upon the

notification and approval of the Civil Service Board. When the Parish President elects to close all Parish

offices as a result of the State and/or Federal government closing its offices, the Civil Service Board must

be notified in writing when declared."

Mr. Terrebonne made a motion to accept the verbiage as presented and it was seconded by Mr.

Wilderson. Motion carried. The proposed change to Civil Service Manual Section 7.01 Holidays was

approved unanimously.

With no further business to be addressed, a motion was made by Dr. Schonberg and seconded by

Mr. Terrebonne to adjourn the meeting. Motion carried. Meeting adjourned.
